

REQUEST FOR QUOTATIONS

ROYAL UNIVERSITY OF PHNOM PENH (RUPP)

Wishes to Purchase:

**SUPPLY, DELIVERY AND INSTALLATION OF
ACCESSORIES AND CONSUMABLES FOR CHEMISTRY AND PHYSICS**

1. The Kingdom of Cambodia has received a Credit from the International Development Association (IDA) toward the cost of Second Higher Education Improvement Project and it intends to apply part of the proceeds of this Credit to payments under the Contract for Supply, Delivery, and Installation of Accessories and Consumables for Chemistry and Physics, Ref: MoEYS-HEIP2-RUPP-NS-G-017.
2. The goods are required to be supplied and delivered **90 calendar days** after the date of **signing the contract**.

Quotation evaluation and qualification criteria are included in the quotation document.
Quotation evaluation and contract award will be on Lot-wise-basis.

3. Interested qualified eligible suppliers are invited to obtain a copy of the quotation documents (Soft Copy) free-of-charge by downloading from the link stated in the IFQ para 8. There shall be no other conditions for obtaining the quotation documents.
4. To be considered eligible and qualified a bidder must:
 - (i) Meet the eligibility criteria of the World Bank.
 - (ii) The Bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years (**2023, 2024 & 2025**) of a value each contract not less than:
 - **LOT #1: USD 21,350.00**
 - **LOT #2: USD 13,040.00**
 - (iii) The Bidder has completed contracts in the preceding two years (**2024 & 2025**) and total cumulative amount equal to at least:
 - **LOT #1: USD 85,370.00**
 - **LOT #2: USD 52,160.00**
 - (iv) Not be under any notice of disbarment issued by the Royal Government of Cambodia or the Development Partner.
5. Quotations must be delivered to the address given below on or before **10:00 am 07th October 2026**. Phnom Penh time. Late Quotations will be rejected. Quotations will be opened in public immediately thereafter at the address given below in the presence of the Bidders' representatives who choose to attend. Bidders shall not have the option of submitting their Quotations electronically.
6. The Purchaser shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated quotation and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.

7. All quotations must be accompanied by a performance securing declaration as described in the bidding documents. Any quotation not accompanied by one will be rejected as non-compliant.
